

The Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013

Instruction to commence work/services within 14 days

To be sent to PBSC if the client requires PBSC to begin (and, where applicable, complete) the supply of a service before the end of the cancellation period (14 days) provided for in regulation 30(1) of The Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013.

Sending this instruction is confirmation of the client's express request for PBSC, where possible, to begin the supply of a service within 14 days. This request places no obligation on PBSC to do so, unless otherwise agreed by PBSC in writing. Beginning the supply of a service is subject to PBSC's availability and conditions of engagement.

Nothing herein affects any other conditions of engagement set out nor any other statutory rights.

I/we the sender* understand that where **The Consumer Contracts (Information, Cancellation and Additional Charges) Regulations 2013** applies, we have a right to cancel within 14 days of entering into an "off-premises contract" with PBSC.

I/we* make this **express requirement for the supply of a service to commence within the cancellation period** therefore, in accordance with the Regulations (Part 3 paragraph 36(4)), if we do subsequently exercise our statutory right under the Regulations to cancel the contract within the cancellation period then we understand the requirement that we must pay to PBSC an amount for the supply of the service (or other costs incurred/committed to) during the period for which it has been supplied, ending with the time when we have informed PBSC of our decision to cancel the contract.

I/we* understand that the amount payable will be calculated as a proportion of the amount of the service that has been undertaken (or supplied) against the total price agreed in the contract. Until otherwise advised, PBSC estimate the following will be the **minimum** amounts payable:

I/we* acknowledge that if having made this **express requirement for the supply of a service to commence within the cancellation period**, and that either the supply of the services has been fully performed or digital content has been supplied not on tangible medium then in accordance with the Regulations (Part 3 paragraph 36(2) and/or 37(2) cease to have the right to cancel.
